We hope your club will send official representatives to the 92nd National Convention of the National Exchange Club in La Quinta, California, July 21-24, 2010. Your club's delegates will elect a National President-Elect, a Regional Vice President (if your club is in Region 2, 4, 6, 8, 10, or 12), and two At-Large Foundation Trustees.

Attached is your club's Convention Voting Credential card. Each chartered Exchange Club in good standing is entitled to representation at the National Convention by the club's president, president-elect, secretary, treasurer and three (3) voting representatives for clubs with up to twenty-five (25) members and one voting representative for each additional twenty-five (25) members. This is based on the membership reported as of March 31st preceding the National Convention.

The club can select alternates for its delegates to ensure full representation if a delegate cannot attend. The alternates'

names should also be entered on the Convention Voting Credential card.

To expedite the convention process for your club's delegates, please complete the Convention Voting Credential card and return to National Headquarters, postmarked by June 1, 2010. Otherwise, representatives from clubs not returning the Credential card will be required to go through the National Convention Committee on Credentials to have their names placed on the official Roll Call.

Upon the return of your completed and signed Convention Voting Credential card, your National Headquarters will verify whether or not your club is considered in good standing and eligible to vote in accordance with Article IX (Conventions), Section 3, of the Bylaws for Local Exchange Clubs.
